The Extraordinary General Meeting of the members of the Company was held on 24th January 2022 at 11:00 a.m. through Video Conferencing (VC) / Other Audio Video Means (OAVM) in compliance with MCA General Circular No. 21/2021 dated 08th December 2021, 20/2020 dated 5th May, 2020 and MCA General Circular No. 02/2021 dated 13th January, 2021.

The Chairman announced that the requisite quorum was present and the meeting was called to order.

The Company Secretary then explained the members of process of casting the voting during the EGM. Then the Company Secretary requested the shareholders attending the meeting and who has not casted their vote earlier through remote e-voting, to cast their vote through e-voting facility provided during the EGM by CDSL on the following items of businesses embodied in the Notice of the Extraordinary General Meeting.

- 1. Increase in Authorized Share Capital of the Company and consequent Alteration in Capital Clause of the Memorandum of Association of the Company.
- 2. Preferential Allotment of Optionally Fully Convertible Debentures ("OFCDs")
- 3. Approval of Lloyds Steels Industries Limited Employee Stock Option Plan 2021 (LLOYDS STEELS ESOP-2021)



- 4. Extension of LLOYDS STEELS ESOP -2021 to eligible employees of the Group companies including Subsidiary(ies), Associate company(ies) and the Holding Company
- 5. Provisioning of Money to "Lloyds Steels Employees Welfare Trust"

The Company Secretary then informed the members that M/s. Hemaantt Maheshwari & Associates had been appointed as the Scrutinizer and to report on the voting results of e-voting for each of the items as per the Notice of the EGM. The Company Secretary then announced that the results of the Remote E-voting and E- Voting at the EGM will be declared at the website of the Company and CDSL.
