A call shall be deemed to have been made at the time whenthe resolution of the Board of Directors authorizing such call was passed and may be made payable by the members whose names appear on the Register of Members on such date or atthe discretion of the Directors on such subsequent date as may be fixed by Directors.

Calls to date resolution

The joint-holders of a share shall be jointly and severally liable to pay all calls in respect thereof.

Liability of Joint-holders

The Board may, from time to time at its discretion, extendthe time fixed for the payment of any call, and may extendsuch time as to all or any of the members who from residenceat a distance or other cause, the Board may deem fairly entitled to such extension, but no member shall be entitled to such extension save as a member of grace and favour.

Directors may extend time

41. Whenever any calls for further share capital are made on shares, such calls shall be made on uniform basis on all shares falling under the same class. For the purposes of this Article shares of the same nominal value of which different amountshave been paid up shall not be deemed to fall under the same class.

If any member fails to pay any call due from him on the day appointed for payment thereof, or any such extension thereofas aforesaid, he shall be liable to pay interest on the samefrom the day appointed for the payment thereof to the time of actual payment at such rate as shall from time to time befixed by the Board, but nothing in this Article shall render it obligatory for the Board to demand or recover any interest from any such member.

43. Any sum, which may by the terms of issue of a share becomes payable on allotment or at any fixed date, whether on account of the nominal value of the share or by way of premium, shall for the purposes of these Articles he deemed to be a call duly made and payable, on the date on which by the terms of issue the same becomes payable and in case of non-payment, allthe relevant provisions of these Articles as to payment of interest and expenses, forfeiture or otherwise, shall apply asif such sum had become payable by virtue of a call duly made and notified.

44. On the trial or hearing of any action or suit brought by the Company against any member or his representatives for the recovery of any money claimed to be due to the Company in respect of his shares, it shall be sufficient to prove that the name of the member in respect of whose shares the money is sought to be recovered, appears entered on the Register of

Provided that moneys paid in advance of calls on any shares may carry interest but shall not confer a right to dividend or to participate in profit.
- (b) No member paying any such sum in advance shall be entitled to voting rights in respect of the moneys so paidby him until the same would but for such payment become presently payable.

- A duly verified declaration in writing that the declarant is a Director of the Company, and that certain shares in the Company have been duly forfeited on a date stated in the declaration shall be conclusive evidence of the facts therein stated as against all persons claiming to be entitled to the shares and such declaration and the receipt of the Company for the consideration, if any, given for the shares on the saleor disposition thereof shall constitute a good title to such shares; and the person to whom any such share is sold shallbe registered as the member in respect of such share and shall not be bound to see to the application of the purchase money, nor shall his title to such share be affected by any irregularity or invalidity in the proceedings in reference to such forfeiture, sale or disposition.

Such nomination shall be governed by the provisions of Section 72 of the Companies Act, 2013 or such other regulations governing the matter from time to time.

Notwithstanding anything contained in Articles of Association for the time being in force or in any disposition, whether testamentary or otherwise, where a nomination made in the manner aforesaid purports to confer on any person the right to vest the shares or debentures, the nominee shall, on the death of the shareholder or debenture holder or as the casemay be on the death of the joint holders become entitled to all the right in such shares or debenture or as the case maybe, all the joint holders, in relation to such shares or debentures, to the exclusion of all other persons, unless the nomination is varied or cancelled in the manner as may be prescribed underthe Act.

Where the Company has come to know through any of its principal officers of the death of any member, the Companyshall, within three months of the receipt of such knowledge, furnish to the Deputy Controller or Assistant Controller of Estate Duty, who is exercising the functions of the Income-tax Officer in the case of the Company, such particulars as may be prescribed by the Estate Duty Rules, 1953.

Every instrument of transfer shall be presented to the Company duly stamped for registration accompanied by such evidence as the Board of Directors may require to prove the title of the transferor, his right to transfer the shares and generally under and subject to such conditions not regulations as the Board of Directors shall from time to time prescribe, and every registered instrument of transfer shall remain in the custody of the Company until destroyed by order of theBoard of Directors.

Conditions of registration of transfer 75. Previously to the registration of a transfer, the certificate or certificates of the share or shares to be transferred must be delivered to the Company along with (same as provided in Section 56 of the Act) a properly stamped and executed instrument of transfer.

The Company shall incur no liability or responsibility whatever in consequence of its registering or giving effect to any transfer of shares made or purporting to be made by any apparent legal owner thereof (as shown or appearing in the Register of Members) to the prejudice of person having or claiming any equitable right, title or interest to or in the said shares, notwithstanding that the Company may have had notice of such equitable right, title or interest or notice prohibiting registration of such transfer, and may have entered such notice, or referred thereto, in any book of the Company, andthe Company shall not be bound or required to regard or attend or give effect to any notice which may be given to it of any equitable right, title or interest, or be under any liability whatsoever for refusing or neglecting so to do, though it may been entered or referred to in some book of the Company; but the Company shall nevertheless be at liberty to regard and attend to any such notice and give effect thereto, if the Boardof Directors shall so think fit.

#### BORROWING POWERS

78. The Board may, from time to time, at its discretion subject to the provisions of Section 180 of the Act, raise or borrow, either from the Directors or from elsewhere and secure the payment of any sum or sums of money for the purpose of the Company; provided that the Board shall not without the sanction of the Company in General Meeting borrow any sum of money which together with money borrowed by the Company (apart from temporary loans obtained from the Company's bankers in the ordinary course of business) exceed the aggregate for the time being of the paid up capital of the Company and its free reserves, that is to say, reserves not set aside for any specific purpose.

79. The Board may raise or secure the repayment of such sum or sums in such manner and upon such terms and conditions in all respects as it thinks fit, and in particular, by the issue of bonds, perpetual or redeemable, debentures or debentures stock, or any mortgage, or other security on the undertaking of the whole or any part of the property of the Company (both present and future), including its uncalled capital for the time being.

Notice of refusal register transfer 81. If the Board refuses to register the transfer of any debentures the Company shall, within one month from the date on which the instrument of transfer was lodged with the Company, send to the transferce and to the transferor notice of the refusal.

The Board shall cause a proper Register to be kept in accordance with the provisions of Section 85 of the Act of all mortgages, debentures and charges specifically affecting the property of the Company, and shall cause the requirements of Sections 77 & 79 of the Act in that behalf to be duly complied with, so far as they fail to be complied with by the Board.

Register and Index of Debenture holders R3. The Company shall, if at any time issues debentures, keep a Register and index of debentureholders in accordance with the provisions of the Act and the details of the members holding debentures both in material an dematerialised fromin any media as permitted by law including electronic media. The Company shall also be entitled to keep in any state or country outside India a Branch Register of Debenture-holders resident in that state or country.

#### SHARE WARRANTS

Power to issue share warrants 84. The Company may issue warrants subject to and in accordance with provisions of the Act and accordingly the Board may inits discretion with respect to any Share which is fully paidupon application in writing signed by the persons registered as holder of the Share, and authenticated by such evidence (if any) as the Board may, from time to time, require as to the identity of the persons signing the application and on receiving the certificate (if any) of the Share, and the amount of the stamp duty on the warrant and such fee as the Board may, from time to time, require, issue a share warrant.

Deposit of share warrants (a) The bearer of a share warrant may at any time deposithe warrant at the Office of the Company, and so longas the warrant remains so deposited, the depositor shallhave the same right of signing a requisition for call in a meeting of the Company, and of attending and voting and exercising the other privileges of a Member at any meeting held after the expiry of two clear days from the time of deposit, as if his name were inserted in the Register of Members as the holder of the Share included in the deposit warrant.

- (b) Not more than one person shall be recognized as depositor of the Share warrant.
- (c) The Company shall, on two day's written notice, return the deposited share warrant to the depositor.

#### CONVERSION OF SHARES INTO STOCK AND RECONVERSION

86. The Company in General Meeting may convert any paid-up shares into stock; and when any shares shall have been converted into stock, the several holders of such stock may hence forth transfer their respective interest therein, or any part of such interest, in the same manner and subject to thesame regulation as, and subject to which shares from which the stock arose might have been transferred, if no such conversion had taken place or as near thereto as circumstances will admit. The Company may at any time reconvert any stock into paid-up shares of any denomination.

Shares may be converted into stock

87. The holders of stock shall, according to the amount of stockheld by them have the same rights, privileges and advantages as regards dividends, voting at meeting of the Company, and other matters as if they held the shares from which the stock arcse; but no such privileges or advantage (except participation in the dividends and profits of the Company and in the assetsof windingup) shall be conferred by an amount of stock which would not, if existing in shares, have conferred that privilege or advantage.

 The Company shall in each year hold a General Meeting asits Annual General Meeting in addition to any other meetings in that year. All General Meetings other than Annual general Meeting shall be Extraordinary General Meetings.

The Board may; whenever it think fit, call an Extraordinary General Meeting and it shall do so upon a requisition in writing by any member or members holding in the aggregatenot less than onetenth of such of the paid-op capital as at the date carries the right of voting in regard to the matter in respect of which the requisition has been made.

90. Any valid requisition so made by members must state the object or objects of the meeting proposed to be called, andmust be signed by the requisitionists and the deposited at the office provided that such requisition may consist of several documents in file from each signed by one or more requisitionists.

91. Upon the receipt of any such requisition, the Board shall forthwith call an Extraordinary General Meeting, and if they do not proceed within twenty-one days from the date of the requisition being deposited at the office to cause meeting tobe called on a day not late than forty-five days from the date

In the case of and Annual General Meeting, if any business other than (i) the consideration of the Accounts, Balance Sheets and Reports of the Board of Directors and Auditors (ii) the declaration of dividend, (iii) the appointment of Directors in place of those retiring (iv) the appointment of and fixing of the remuneration of the Auditors, is to be transacted, and incase of any other meeting, in any event there shall be annexed to the notice of the Meeting a statement out all material facts concerning each such item of business including, in particular, the nature of concern or interest, if any, therein of every director, and the Manager (if any) where any such item of special business related to or affects any other Company, the extent of share-holding interest in other company of every Director and the Manager, if any, of the Company shall alsobe set out in the statement if the extent of such shareholding interest is not less than 20 per cent of the paid-up share capital of that other company. Where any item of business consists of the according of approval to any document by the meeting, the time and place where the document can be inspected shall be specified in the statement aforesaid.
- 94. The accidental emission to give any such notice as aforesaid to any of the members, or the non-receipt thereof, shall notinvalidate any resolution passed at any such meeting.

Omission to give notice not to invalidate a resolution passed

 No General Meeting, Annual or Extraordinary, shall be competent to enter upon, discuss or transact any business which has not been mentioned in the notice or notices upon which it was convened.

Meeting not to transact business not mentioned in notice

 Quorum shall be minimum members required to be presentat the General Meeting as per provisions of the Act. Quorum

 A body corporate being a member shall be deemed to be personally present if it is represented in accordance with Section 113 of the Act. Body Corporate deemed to be personally present

98. If, at the expiration of half an hour from the time appointedfor holding a meeting of the Company, a quorum shall not be present, the meeting, if convened by or upon the requisition of members shall stand dissolved, but in any other case themeeting shall stand adjourned to the same day in the next or, if that day is a public holiday, until the next succeeding day which is not a public holiday, at the same time and place, orto such other day and at such other time and place in the cityor two in which the office of the Company is for the time being situate, as the Board may determine and if at such adjourned meeting a quorum is not present at the expiration of half an hour from the time appointed for holding the meeting, the members present shall be quorum and may transact the business for which the meeting was called.

If quorum not present meeting to be dissolved or adjourned.

99. The Chairman (if any) of the Board shall be entitled to takethe chair at every General Meeting, whether Annual of Extraordinary. If there be no such Chairman of the Board, orif at any meeting he shall not be present within filteen minutesof the time appointed for holding such meeting, or if he shallbe unable or unwilling to take the chair, then the directors present may choose one of their number to be the Chairmanof the meeting. If no director be present or if all the directors present decline to take the chair, then the Members presentshall elect one of their number to be Chairman.

Chainnan of a General Meeting.

 No business shall be discussed at any General Meeting except the election of a Chairman, while the Chair is vacant.

Business confined to election of Chairman while chair vacant.

101. The Chairman with the consent of the members may adjourn any meeting from time to time and from place to place in the city in which it is held but, no business shall be transacted at any adjourned meeting other then the business left unfinished the meeting from which the adjournment took place. Whena meeting is adjourned for thirty days or more, notice of the adjourned meeting shall be given as in the case of an original meeting.

Chairman with consent may adjourn meeting.



Save as aforesaid, and as provided in section 103 of the Act, it shall not be necessary to give any notice of an adjournment orof the business to be transacted at an adjourned meeting,

E-voting

102. A member may exercise his vote at a meeting by electronic means in accordance with section 108 and shall vote only once.

Chairman's casting vote.

103. In the case of an equality of votes, the Chairman shall have a custing vote in addition to the vote or votes to which he maybe entitled as a member.

Poil to be taken if demanded 104. If a poll is demanded as aforesaid the same shall, subject to Article 103 be taken at such time (not later than forty eighthours from the time when the demand was made) and placein the city or town in which the office of the Company is for the time being situated and either by open voting or by ballot, as the Chairman shall direct, and either at once or after an interval or adjournment or otherwise, and the result of the poll shall be deemed to be the resolution of the meeting atwhich the poll was demanded. The demand for a poll may be withdrawn at any time by the person or persons who madethe demand.

Scriptimeers at Hog.

105. Where a poll is to be taken, the Chairman of the meeting shall appoint two scrutineers to scrutinize the vote given on the poll and to report thereon to him. One of the scrutineersso appointed shall always be a member present at the meeting provided such a member is available and willing to be appointed. The Chairman shall have power at any time before the result of the poll is declared to remove a scrutineer from office and fill vacancies in the office of senatineer arising from each removal or from any other couse.

In what case poll taken without adjournment

- Demand for poll not to prevent transaction of other business
- 106. Any poll duly demanded on the election of Chairman of meeting or on any question of adjournment shall be taken atthe meeting forthwith.

107. The demand for a poll except on the questions of the electionof the Chairman and of an adjournment shall not prevent the continuance of a meeting for the transaction of any businessother than the question on which the poll has been demanded.

## VOTES OF MEMBERS

- Members in arrears not to **VODE**
- 108. No member shall be entitled to vote either personally or byproxy, at any General Meeting or Meeting, of a class of share holders, either upon a show of hands or upon a poll in respectof any shares registered in his name on which any calls orother sums presently payable by him have not been paid or, regard to which the Company has, and has exercised any right of lien.
- 109. The Company may and in the case of resolution relating tosuch business as the Central Government may, by notification,

declare to be conducted only by postal ballot, shall, get any resolution passed by means of a postal ballot, instead of transacting the business in general meeting of the Company. Where the Company requires to or decides to, as the case may be get a resolution passed by means of a postal ballot, the provisions of Section 110 of the Act or such other rules, regulations and modifications framed thereunder from time to time shall be complied with.

110. A Depository shall be deemed to be the registered owner forthe purpose of effecting transfer of ownership of shares or debentures on behalf of a Beneficial Owner. Save as otherwise provided herein above, the Depository as a registered owner shall not have any voting rights or any other rights in respectof Shares held by it and the Beneficial Owner shall be entitled to all the rights and benefits and be subject to all the liabilities in respect of its shares held by a Depository.

Voting Right of Depositories and Beneficial Owners

111. Subject to the provisions of these Articles and without prejudice to any special privileges or restrictions as to voting for the time being attached to any class of shares for the time being forming part of the Capital of the Company, every member not disqualified by the last preceding Article shall be entitled to be present, and to speak and vote at such meeting, every member present in person shall have one vote and upona poll the voting rights of every member present in person orby proxy shall be in proportion to his shares of the paid-up equity share, capital of the Company. Provided, however, if any preference shareholder be present at any meeting of the Company, save as provided in Section 47, he shall have a right to vote only on resolutions placed before the meeting which directly affect the rights attached to his preference shares.

Numbers of vote which Member entitled

112. On a poll taken at meeting of the Company a member entitled to more than one vote, or his proxy or other person entitled to vote for him, as the case may be, need not, if he votes, use all his votes or east in the same way all the votes he used.

Casting of votes by a member entiled to more than one vote. How members non-compos mentils and minor may

113. A member of unsound mind or in respect of whom an orderhas been made by any Court having jurisdiction in lunacy may vote by his committee or other legal guardian and anysuch committee or guardian may, on poll vote by proxy, if any member be a minor, the vote in respect of his share or shares shall be by his guardian, or any one of his guardians, if more than one, to be selected in case of dispute by the Chairman of the meeting.

Votes of joint member

114. If there be joint holders of any shares, any one of such person may vote at any meeting or may appoint another person (whether a member or not) as his proxy in respect of such shares, as if he were safely emitted thereto but the proxy so appointed shall not have any right to speak at the meeting.



and, if more than one of such joint holders be present at any meeting that one of the said persons so present whose name stands higher on the Register shall alone be entitled to speak and to vote in respect of such shares, but the other or othersof the joint-holders shall be entitled to be present at the meeting. Several executors or administrators of a deceased member in whose name shares stand shall for the purpose of these Articles to be deemed joint holders thereof.

Voting in person or hy proxy 115. Subject to the provisions of these Articles, votes may be given either personally or by proxy. A body corporate being a member may vote, either by a proxy or by a representative duly authorised in accordance with Section 113 of the Act, and such representative shall be entitled to exercise the same rights and powers (including the rights to vote by proxy) on behalf of the body corporate which he represents as the body could exercise if it were an individual member.

Votes in respect of shares of deceased and insolvent member

116. Any person entitled under Article 71, to transfer any share may vote at any General Meeting in respect thereof in the same manner, as if he were the register holder of such shares, provided that forty eight hours atleast before the time of holding the meeting or adjourned meeting, as the case may be at which he proposes to vote he shall satisfy the Directors of his right transfer such shares and give such indemnity (ifnny) as the Directors may require or the Directors shall have previous admitted his right to vote at such meeting in respect thereof.

Appointment of proxy

117. Every proxy (whether a member or not) shall be appointed in writing under the hand of the appointer or his attorney, or if such appointer is a corporation under the common scal of such corporation or be signed by an officer or any attorneyduly authorised by it, and any Committee or guardian may appoint such proxy. The proxy so appointed shall not have any right to speak at the meetings.

Proxy either for specified moeting or a period

- 118. An instrument of proxy may appoint a proxy either for thepurpose of a particular meeting specified in the instrument and any adjournment thereof or it may appoint for the purpose of every meeting of the Company, or of every meeting to be held before a date specified in the instrument and every adjournment of any such meeting.
- 119. A member present by proxy shall be entitled to vote only on a poll.

Proxy to vote only on a poil.

Deposit of instrument of appointment 120. The instrument appointing a proxy and the power of attorneyor other authority (if any) under which it is signed or a notarially certified copy of that power or authority shall be deposited at the office not later than forty-eight hours beforethe time for holding the meeting at which the person named in the instrument proposes to vote, and in default the instrument of proxy shall not be treated as valid. 121. Every instrument of praxy whother for a specified meeting or otherwise shall, as nearly as circumstances will admit, be inany of the forms set out in Section 105 of the Act.

Form of prexy

122. A vote give in accordance with the terms of an instrument of proxy shall be valid notwithstanding the previous death or insanity of the principal, or revocation of the proxy of anypower of attorney under which such proxy was signed or the transfer of the share in respect of which the vote is given, provided that no intimation in writing of the death or insanity, revocation or transfer shall have been received at the office before the meeting.

Validity of vote given by proxy notwithstanding death of Member

123. No objection shall be made to the validity of any vote exceptat any meeting or poll at which such vote shall be tendered, and every vote whether given personally or by proxy, not disallowed at such meeting or poll shall be deemed valid forall purposes of such meeting or poll whatsoever.

Time for objection of votes

124. The Chairman of any meeting shall be sole judge of the validity of every vote tendered at such meeting. The Chairman presentat the taking of a poll shall be the sole judge of the validity of every vote tendered at such poll.

Chairman of the meeting tube the judge of validity of any vote

125. (1) The Company shall cause minutes of all proceedings of every General Meeting to be kept by making, within thirty days of the conclusion of every such meeting concerned, entries thereof in books kept for that purpose with their pages consecutively numbered.

Minutes of General Meeting and Inspection thereof by members.

- (2) Each page of every such book shall be intialled or signed and the last page of the record of proceedings of such meeting in such books shall be dated and signed by the Chairman of the same meeting within the aforesaid period of thirty days or in the event of the death or Liability of that Chairman within that period, by a Director duly authorised by the Board for the purpose.
- (3) In no case the minutes of proceedings of a meeting shallbe attached to any such book as a foresaid by pasting or otherwise.
- (4) The minutes of each meetings shall contain a fair andcorrect summary of the proceedings therest.
- (5) All appointments of Officers made at any meeting aforesaid shall be included in the minutes of the meetings.
- (6) Nothing herein contained shall require or he deemed to require the inclusion in any such minutes of any matter which in the opinion of the Chairman of the meeting:-



- is or could reasonably be regarded, as, defamatory of any person, or
- (b) is irrelevant or immaterial to the proceeding, or
- (c) is detrimental to the Interest of the Company.

The Chairman of the meeting shall exercise an absolute discretion in regard to the inclusion or noninclusion of any matter in the minutes on the aforesaid grounds.

- Any such minutes shall be evidence of the proceedings recorded therein.
- (8) The book containing the minutes of proceedings of General Meeting shall be kept at the office of the Company and shall be open during business hours for such periods not being less in the aggregate than twohours in each day as the Directors determine, to the inspection of any member without charge.

## DIRECTORS

Number of Directors: 126. Until otherwise determined by a General Meeting of the Company and subject to the provisions of Section 149 and 151of the Act, the number of Directors (excluding nominees/ special/debenture and alternate Directors) shall not be less than three nor more than fifteen. Provided that a company may appoint more than fifteen directors after passing a special resolution.

Nominee Directors 127. If at any time the Company obtains any loans or any assistance in connection therewith by, way of guarantee or otherwise from any person, firm, body corporate, local authority or public body (hereinafter called "the institution") or if any time the Company issues any shares, debentures and enters into any contract or arrangement with the institution whereby the institution subscribes for or underwrites the issue of the Company's shares or debentures or provides any assistance to the Company in any manner and it is a term of the relative loan, assistance, contract or agreement that the institution shall have the right to appoint one or more Directors to the Board of the Company, then subject to the provisions of Section

161 of the Act and subject to the terms and conditions of such loan, assistance, contract or arrangement the institution shall be entitled to appoint one or more Director or Directors, as the case may be, to the Board of the Company and to remove from office any Director so appointed and to appoint another in his place or in the place or Director so appointed who resigns or otherwise vicates his office. Any such appointmentor removal shall be made in writing and shall be served at the office of the Company. The Directors or Directors so appointed shall neither be required to hold any qualifications have nor be liable to retire by rotation and shall continue in

office for so long as the relative loan, assistance, contract or arrangement, as the case may be, subsists.

128. If it is provided by the Trust Deed, securing or otherwise in connection with any issue of debentures of the Company, that any person or persons shall have power to nominate a Director of the Company, then in the case of any and every such issueof debenture, the person or persons having such power may exercise such power from time to time and appoint a Director accordingly. Any Director so appointed is herein referred to as Debenture Director. A Debenture Director may be removed from office at any time by the person or persons in whom for the time being is vested the power under which he was appointed and another Director may be appointed in his place. A Debenture Director shall not be liable to retire by rotation. A Debenture Director shall not be bound to hold any qualification shares.

Debenture

129. The Company may have a director elected by small shareholderin the manner as may be prescribed under the provisions of Section 151 of the Act, or such other regulations governing the matter from time to time. The director so elected will be a Ex-officio Director.

Appointment of Small Shareholders' Director

130. The Board may appoint an Alternate Director to act for a Director (hereinafter called "the Original Director") during his absence for a period of not less than three months fromthe State in which the meetings of the Board are ordinarilyheld. An Alternate Director appointed under this Article shallnot hold office for a period longer than that permissible to the Original Director in whose place he has been appointed and shall vacate office of the Original Director are returns to that State. If the terms of office of the Original Director are determined before he so returns to that State, any provisions in the Act or in these Articles for his automatic reappointment of any retiring Director in default of another appointment shall apply to the Original Director and not to the Alternate Director.

Appointment of Alternate Directors

131. A person shall not be capable of being appointed as a Directorof the Company, if any of the provisions of the disqualification prescribed under Section 164 of the Act, applies to him.

Disqualification of Director

132. Subject to the provisions of Section 161 of the Act, the Board shall have power at any time and from time to time to appoint my other qualified person to be an Additional Director, but so that the total number of Directors shall not at any time exceed the maximum fixed under the Article 126. Any suchAdditional Director shall hold office only up to the date of the next Annual General Meeting.

Additional Directors

133. Until otherwise determined by the Company in General Meeting, a Director shall not be required to hold any sharesin the capital of the Company as his qualification.

Share qualification of Directors

Directors can not before acquiring qualification 134. Without prejudice to the restrictions imposed by the Act. a Director who is required to hold qualification shares may actas a Director before acquiring such shares but shall, if he isnot already qualified, obtain his qualification, and every director other than a Director appointed by the Central or aState Government shall file with the Company a declaration specifying the qualification shares held by him within two months from his appointment as a Director.

Director's power to fill casual vacancies 135. Subject to the provisions of the Act, the Board shall have power at any time and from time to time to appoint any other qualified person to be a Director to fill a casual vacancy. Any person so appointed shall hold office only up to the date to which the Director in whose place he is appointed would have held office if it has not been vacated by him.

Remuneration of Directors Travelling expenses incurred by Director not a bonafide resident or by Director going on on Company's business.

- 136. (1) Subject to the provisions of the Act, a Managing Director or Managing Directors, who is in the whole-time employment of the Company may be paid remunerationeither by way of a monthly payment or at a specified percentage of the net profits of the Company or partlyby one way and partly by the other.
  - (2) Subject to the provisions of the Act, a Director who is neither in the whole-time employment nor a Managing Director, may be paid remuneration either.
    - by way of monthly, quarterly or annual paymentwith the approval of the Central Government, or
    - (ii) by way of commission if the Company by a special resolution authorised such payment.
  - (3) The minimum remuneration of a Director for his services shall be such sum as may be prescribed by the Act ortho Central Government from time to time for each meeting of the Board of Directors attended by him.
- 137. The Board may allow and pay to any Director who is not a bonafide resident of the place where the meetings of the Board are ordinarily held and who shall come to such place for the purpose of attending any meeting, such sum as the Board may consider fair compensation for travelling, boarding, lodging and other expenses, in addition to his fee for attending such meeting as above specified; and if any Director be called upon to go or resided out of the ordinary place of his residence on the Company's business, he shall be entitled to be repaidand reimbursed any travelling or other expenses incurred in connection with business of the Company.

Directors may act notwithstanding any vacancy 138. The continuing Directors may act notwithstanding any vacancyin their body but if, and so long as their number is reduced below the minimum number fixed by the Article 126 hereof, the continuing Directors not being less than two, may act forthe purpose of increasing the number of Directors to the

139. (1) The office of a Director shall ipso facto be vacated if:-

Vacation of office of Director

- (a) he is found to be of unsound mind by a Court of competent jurisdiction; or

- (c) he is adjudged an insolvent; or
- (d) he is convicted by a Court in India of any offence and is sentenced in respect thereof to imprisonment for not less than six months; or
- (e) he fails to pay any calls in respect of shares of the Company held by him, whether alone or jointly with others, within six months from the last datefixed for the payment of the call; or
- (f) he absents from three consecutive meetings of the Boardor from all meetings of the Board for a continuous period of three months, whichever is the longer, without obtaining leave of absence from the Board; or
- (g) he or any firm of which he is a partner or any private company of which he is a director, acceptsaloan, or any guarantee or security for a loan, from the Company in contravention of Section 185of the Act;
- (h) he acts in contravention of Section 184 of the Act, or
- he be removed from office in pursuance of Section 169 of the Act, or
- by notice in writing to the Company he resigns his office;
   or
- (k) any office or place of profit under the Company or under any subsidiary of the Company is held in contravention of Section 188 of the Act and by operation of that Section he is deemed to vacateoffice.
- (2) Notwithstanding any matter or thing in subclauses (c), (d) and (i) of clause (1), the disqualification referred to in those sub-clauses shall not take effect:-
  - for thirty days from the date of adjudication sentence or order, or
  - (b) Where an appeal or petition is preferred within

the thirty days aforesaid against the adjudication, sentence or conviction resulting in the sentence, or order until the expiry of seven days from the date on which such appeal or petition is disposed of; or

(e) where within the seven days aforesaid any further appeal or petition is preferred in respect of the adjudication, sentence, conviction or order, and theappeal or petition, if allowed, would result in the removal of the disqualification until such further appeal or petition is disposed of.

# Disclosure of

140. A Director of the Company who is in any way, whether directly or indirectly concerned or interested in a contract or proposed contract or arrangement entered into or to be entered into byor on behalf of the Company, shall disclose the nature of his concern or interest at a meeting of the Board in the manner provided in Section 184 of the Act; provided that it shall not be necessary for a Director to disclose his concern or interest in any contract or arrangement entered into or to be enterediato with any other company where any of the Directors of the Company or two or more of them together holds or holdnot more than two per cent of the paid-up share capital inany such other company.

## General notice of interest

141. A General Notice given to the Board by the Directors, to the effect that he is a director or member of a specified body corporate or is a member of a specified firm and is to be regarded as concerned or interested in any contract or arrangement which may, after the date of the notice, be entered into that body emporate of firm shall be deemed to be sufficient disclosure of concern or interest in relating to any contract or arrangement so made. Any such general notice shall expire at the end of the financial year in which it isgiven but may be renewed for a further period of one financial year at a time by a fresh notice given in the last month of the financial year at a time by a fresh notice given in the last month of the financial year at a meeting of the Board or the Director concerned takes reasonable steps to secure that it is brought up and read at the first meeting of the Board after it is given.

Interested Directors not to participate or vote in Board's proceedings

- 142. No Director shall as Director take any part in the discussionof, or vote on any contract or arrangement entered into by oron behalf of the Company, if he is in any way, whether directly or indirectly concerned or interested in such contract or arrangement; nor shall his presence count for the purpose offorming a quorum at the time of any such discussion or vote; and if he does vote, his vote shall be void; provided however, that nothing herein contained shall notly to:-
  - (a) any contract of indemnity against any loss which the Directors or any one or more of them, may suffer by



reason of becoming or being sureties or a surety for the Company.

- (b) any contract or arrangement entered into or to be entered into with a public company or a private company whichis a subsidiary of a public company in which the interest of the Director consists solely:
  - (i) in his being:-
    - (a) a director of such company, and
    - (b) the holder of not more than shares of such number of value therein as is requisite to qualify him for appointment as a Director thereof, be having been nominated as such Director by the Company.

OF

- in his being a member holding not more than 2% of its paid-up share capital.
- 143. The Company shall keep a Register in accordance with Section 189 and shall within the time specified under Section 189 enter therein such of the particulars as may be relevant. The Register aforesaid shall also specify in relation to each Director of the Company the names of the bodies corporate and firmsof which notice has been given by him under Article 140. The Register shall be kept at the office of the Company and shall be open to inspection at such office, and extracts may be taken therefrom and copies thereof in same manner, and on payment of the same fee as in the case of the Register of Members of the Company and the provision of Section 94 ofthe Act shall apply accordingly.

Register of contracts in which Directors are interested

144. At every Annual General Meeting of the Company, one-thirdof such of the Directors for the time being as are liable retire by rotation or if their number is not three or a multipleof three, the number nearest to one-third shall retire from office.

Retirement and rotation of Directors

145. Subject to the Act, the Directors to retire by rotation underArticle. 144 at every Annual General Meeting shall be thosewho have been longest in office since their last appointment, but as between persons who became Directors on the same day, those who are to retire, shall, in default of, and subjectio any agreement among themselves, be determined by lot.

Ascertainment of Directors retiring by rotation and filling of vacancies

146. A retiring Director shall be eligible for re-election,

147. (a) If the place of the retiring Director is not so filled upand the meeting has not expressly resolved not to fillthe vacancy the meeting shall stand adjourned until the same day in the next week, at the same time and place. Eligibility for re-election Provision and default of appointment

- (b) If at the adjourned meeting also, the place of the retiring Director is not filed up and that meeting also has not expressly resolved not to fill the vacancy, the retiring Director shall be deemed to have been reappointed at the adjourned meeting, unless:
  - at that meeting or at the previous meeting the resolution for the reappointment of such Director has been put to the meeting and lost;
  - the retiring Director has, by a notice in writing addressed to the Company or its Board expressedhis unwillingness to be so reappointed;
  - (iii) he is not qualified or is disqualified for appointment;
  - (iv) a resolution whether special or ordinary, is required for the appointment or reappointment by virtue of any provisions of the Act. or
  - (v) the provision of Section 162 of the Act is applicable to the case.

Company may increase or reduce the number of Directors 148. Subject to Section 149 of the Act, the Company may, fromtime to time, increase or reduce the number of Directors, and may after their qualifications and the Company may (subject to the provisions of Section 169 of the Act) remove any Directorbefore the expiration of his period of office and appoint another qualified person in his stead. The person so appointed shall hold Office during such time as the Director in whose placehe is appointed would have held the same if he had not been removed.

Notice of candidate for office of Directors except in certain cases

- 149. (1) No persons not being a retiring Director, shall be eligible for appointment to the office of Director at any General Meeting unless he or some member intending to propose him has, not less than fourteen days before the meetingleft at the office of the Company a notice in writing under his hand signifying his candidature for the office of Director or the intention of such member to proposehim as a candidate for that office along with a deposit of One Lac rapees which shall be refunded to such personor as the case may be, to such member if the person succeeds in getting elected as a Director.
  - (2) Every person (other than a director retiring by rotationor otherwise or a person who has left at the office of the Company a notice under Section 160 of the Act signifying his candidature for the office of a Director) proposed as a candidate for the office of a Director, shall sign and file with the Company, the consent in writing to act as a Director, if appointed.



150. (a) The Company shall keep at its office a Register containing the particulars of its Directors, Managers, Secretaries and other persons mentioned in Section 170 of the Act, and shall otherwise comply with the provisions of the said Section in all respects.

Register of Directors etc. and notification of change to Registrar

(b) The Company shall in respect of each of its Directors also keep at its office a Register, as required by Section 170 of the Act, and shall otherwise duly comply with the provisions of the said Section in all respects. Registers of shares or debentures held by Directors.

151. Every Director or Managing Director or Manager, or Secretaryof the Company, shall upon his appointment to any of the offices in any other body corporate, disclose to the Company, the particulars relating to his office in the other body corporate which are required to be specified under Section 184 of the Act.

Disclosure by Directors of appointment only other body corporate.

## MANAGING DIRECTOR/ WHOLE-TIME DIRECTOR

152. Subject to the provisions of the Act and of these Articles, the Board shall have power to appoint from time to time any offits member as Managing Director or Managing Directors of the Company for fixed term not exceeding five years at a time and upon such terms and conditions as the Board thinks fit, and subject to the provisions of Article 153, the Board may by resolution vest in such Managing Director or Managing Directors, such of the powers hereby vested in the Board generally as it thinks fit, and such powers may be made exercisable for such period or periods, and upon such conditions and subject to such restrictions as it may determine. The remuneration of a Managing Director may be by way of monthly payment, fee for each meeting or participation in profits, or by any or all these modes, or any other mode not expressly prohibited by the Act.

Board may appoint Managing Director or Managing Directors

- 153. The Managing Director or Managing Directors shall not exercise the powers to:
  - make calls on share holders in respect of money unpaidon the shares in the Company.

Restriction on management

- issue debentures; and except to the extent mentioned in the resolution passed at the Board meeting under Section 179 of the Act, shall also not exercise the powers to;
- (c) borrow moneys, otherwise than on debentures,
- (d) invest the funds of the Company, and
- (e) make loans.
- 154. Subject to the provisions of the Act and of these Articles, the Board shall have power to appoint from time to time any ofits member as Whole-time Director or Whole time Directors

Whole-time Director

of the Company for fixed term not exceeding five years at atime and upon such terms and conditions as the Board thinksfit, the Board may by resolution vest in such Whole-time Director or Whole-time Directors such of powers hereby vested in the Board generally as it thinks fit, and such powers maybe made exercisable for such period or periods, and upon such conditions and subject to such restrictions as it may determine. The remuneration of a Whole-time Director shall be subject to the extent provisions of the Companies Act, 2013, applicable from time to time and may be by way of monthly payment, fee for each meeting or participation in profits, or by any orall these modes, or any other mode not expressly prohibited by the Act.

Certain persons not to be appointed.

- The Company shall not appoint or employ, or continue the appointment or employment of a person as its Managing or whole-time Director who-
  - is an undischarged insolvent, or has at any time been adjudged as insolvent;
  - (b) suspends, or has at any time Suspended, payment to his creditors, or makes, or has at any time made, a compromise with them; or
  - is, or has at any time been convicted by Court, of an offence involving moral turpitude.

Holding of Office

- 156. The Managing Director or Managing Directors or whole-time Director or whole-time Directors so appointed shall be liable to retire by rotation. A Managing Director or Whole-time Director who is appointed as Director immediately on the retirement by rotation shall continue to hold his office as Managing Director or Whole-time Director and such re-appointment as such Director shall not be deemed to constitute break in his appointment as Managing Director or Whole-time Director.
- 157. Subject to the provisions of the Act and Article 152 of these Articles, the Managing Director or Whole Time Director maybe appointed as Chairman of the Company and hold such position till the period as may be decided by the Board.

## PROCEEDINGS OF THE BOARD OF DIRECTORS

Meetings of Directors

- 158. The Directors may meet together as a Board for the dispatchof business from time to time, and shall so meet at least oncein every three months and at least four such meetings shallbe held in every year. The Directors may adjourn and otherwise regulate their meetings as they think fit.
- 159. Notice of every meeting of the Board shall be given in writingto every Director for the time being in India, and at his usual address in India; to every other Director.

160. The Secretary shall, as and when directed by the Directors todo so convene a meeting of the Board by giving a notice in writing to every other Director.

When meeting to be convened

161. The Board shall appoint a Chairman of its meetings and determine the period for which he is to hold office. If no Chairman is appointed, or if at any meeting of the Board the Chairman be not present within five minutes after the time appointed for holding the same, the Directors present shall choose someone of their member to be Chairman of such meeting.

Chairman

162. The quorum for a meeting of the Board shall be determinedfrom time to time in accordance with the provisions of Section 174 of the Act. If a quorum shall not be present within fifteen minutes from the time appointed for holding a meeting of the Board it shall be adjourned until such date and time as the Chairman of the Board shall appoint.

Ouorum

163. A Meeting of the Board at which a quorum be present shallbe competent to exercise all or any of the authorities, powersand discretions by or under these Articles for the time being vested in or exercisable by the Board.

Powers of Quorum

164. Subject to the provisions of the Act, questions arising at any meeting shall be decided by a majority of votes, and in case of any equality of votes, the Chairman shall have a second oreasting vote.

How questions to be decided

165. The Board may subject to the provisions of the Act, from time to time and at any time delegate any of its powers to a committee consisting of such 'Director or 'Directors as it thinks fit, and may from time to time revoke such delegation. Any Committee so formed shall, in the exercise of the powers so delegated, conform to any regulations that may from time to time be imposed upon it by the Board.

Power to Appoint Committee and to delegate

166. The meetings and proceedings of any such Committee consisting of two or more members shall be governed by the provisions herein contained for regulating the meetings and proceedings of the Board so far as the same are applicable thereto, \*and are not superseded by any regulations made by the Board under the Article 164.

Proceedings of Committee

167. Save in those cases where a resolution is required by the Act,to be passed at a meeting of the Board, a resolution shall be a valid and effectual as if it had been passed at a meeting offhe Board or Committee of the Board, as the case may be,duly called and constituted, if a draft thereof in writing is circulated, together with the necessary papers, if any, to all the Directors, or to all the members of the Committee of the Board, as the case may be, then in India (not being less in number than the quorum fixed for a meeting of the Board or Committee, as the case may be) and to all other Directors or

members of the Committee at their usual address in India, and has been approved by such of them as are then in India, or by a majority of them as are entitled to vote on the resolution.

- Acts of Board or Committee valid notwithstanding informal appointment.
- 68. All acts done by any meeting of the Board or by a Committee of the Board or by any person acting as a Director shall notwithstanding that it shall afterwards be discovered that there was some defect in the appointment of such Director or persons acting as aforesaid, or that they or any of them were disqualified or had vacated office or that the appointment of any of them had been terminated by virtue of any provisions contained in the Act or in these Articles, be as valid as if every such person had been duly appointed, and was qualified to be a Director and had not vacated his office or his appointment had not been terminated; provided that nothing in this Article shall be deemed to give validity to acts done by a Director after his appointment has been shown to the Company to be invalid or to have been terminated.

Minince of proceedings of Meetings of the Beard

- 169. (1) The Company shall cause minutes of all proceedings of every meeting of the Board and Committee thereof to be kept by making within thirty days of the conclusion of every such meeting entries thereof in books kept for that purpose with their pages consecutively numbered.
  - (2) Each page of every such book shall be initialled or signed and the last page of the record of proceedings of each meeting in such book shall be dated and signed by the Chairman of the said meeting or the Chairman of the next succeeding meeting.
  - (3) In no case shall the minutes of proceedings of a meetingbe attached to any such book as aforesaid by a pastingor otherwise.
  - (4) The minutes of each meeting shall contain a thir and correct summary of the proceedings thereat.
  - (5) All appointments of officers made at any of the meetings aforesaid shall be included in the minutes of the meetings.
  - (6) The minutes shall also contain :
    - (a) The names of the Directors present at the meeting; and
    - (b) in the case of each resolution passed at the meeting the names of the Directors, if any, dissenting fromer not concurring in the resolution.
  - (7) Nothing contained in sub-clauses(1) to (6) shall be deemed to require the inclusion in any such minutes of any matter which, in the opinion of the Chairman of the meeting:

- is, or could reasonably be regarded as defimatory of any person;
- (b) is irrelevant or immaterial to the proceedings; or
- (c) is detrimental to the interest of the Company.

The Chairman shall exercise an absolute discretion in regard to the inclusion or non-inclusion of any matter in the minutes on the grounds specified in this sub-clause.

- (8) Minutes of meetings kept in accordance with the aforesaid provisions shall be evidence; of the proceedings recorded therein.
- 170. The Board may exercise all such powers of the Company anddo all such acts, and things as are not, by the Act, or anyother Act, or by the Memorandum, or by the Articles of the Company, required to be exercised by the Company in General Meeting subject nevertheless to these Articles, to the provisions of the Act, or any other Act and to such regulations being not inconsistent with the aforesaid regulations or provisions, as may be prescribed by the Company in General Meeting but no regulations made by the Company in General Meeting shall invalidate any prior act of the Board which would have been valid if that regulation had not been made; Provided that the Board shall not, except with the consent of the Company in General Meeting:

Power of Directors

- (a) sell, lease or otherwise dispose of the whole, or substantially the whole of the undertaking of the Company, or where the Company owns more than one undertaking, of the whole, or substantially the whole of any such undertaking;
- (b) remit, or give time for the repayment of any debt due by a Director:
- (c) invest otherwise than in trust securities the amount of compensation received by the Company in respect of the compulsory acquisition of any such undertaking as is referred to in clause(a), or of any premises or properties used for any such undertaking and without which it cannot be carried on or can be carried on only with difficulty or only after a considerable time.
- (d) borrow moneys where the moneys to be borrowed together with the moneys already borrowed by the Company (apart from temporary loans obtained from the Company's bankers in the ordinary course of business), will exceed the aggregate of the paid up capital of the Company and its free reserves that is to say, reserves not set apart for any specific purpose Provided further that the powers specified in Section 179 and 180of the Act shall, subject to these Articles, be exercised only at meetings of the Board, unless the same be delegated to the extent there in stated; or



- (e) contribute to charitable and other funds not directly relating to the business of the Company or the welfareof its employees, in accordance with the provisions of Sections 181 of the Act.
- 171. Without prejudice to the general powers conferred by the last preceding. Article and so as not in any way to limit or restrict those powers, and without prejudice to the other powers conferred by these Article, but subject to the restrictions contained in the last preceding Article, it is hereby declared that the Directors shall have the following powers; that is tosay, power -
  - To pay the costs, charges and expenses preliminary and incidental to the promotion, formation, establishment and registration of the Company;
  - (2) To pay any charge to the capital account of the Company and Commission or interest lawfully payable thereout.
  - (3) Subject to the provisions of the Act to purchase or otherwise acquire for the Company any property, rights, or privileges which the Company is authorised to acquire, at or for such price or consideration and generally onsuch terms and conditions as they may think fit; and inany such purchase or other acquisition to accept such title as the Directors may believe or may be advised to be reasonably satisfactory;
  - (4) At their discretion and subject to the provisions of the Act to pay for any property, rights, or privileges acquired by or services rendered to the Company, either wholly or partially, in each or in shares, bonds, debentures, mortgages, or other securities of the Company, and such shares may be issued either as fully paid up or with such amount credited as paid up thereon as may be agreed upon; and any such bonds debentures, mortgages or other securities may be either specially charged uponall or any part of the property of the Company and its uncalled capital or not so charged;
  - (5) To secure the fulfilment of any contracts or engagement entered into by the Company by mortgage or charge of all or any of the property of the Company and its uncalledcapital for the firm being or in such manner as they may think fit:
  - (6) To accept from any members, as far as may be permissible by law, a surrender of his shares or any part thereof, on such terms and conditions as shall beagreed;
  - (7) To appoint any person to accept and hold in trust forthe Company any property belonging to the Company, in which it is interested, or for any other purposes; and execute and do all such deeds and things as may be

- required in relation to any trust, and to provide for the remuneration of such trustee or trustees;
- (8) To institute, conduct, defend, compound, or abundon any legal proceedings by or against the Company or its officers, or otherwise concerning the affairs of the Company, and also to compound and allow time for payment or satisfaction of any debts due, and of any claim or demands by or against the Company and to refer any differences to arbitration, and observe and perform any awards made thereon;
- (9) To act on behalf of the Company in all matters relatingto bankrupts and insolvents;
- (10) To make and give receipts, releases, and other discharges for moneys payable to the Company and for the claimsand demands of the Company;
- (11) Subject to the provisions of Section 186 of the Act, to invest and deal with any moneys of the Company not immediately required for the purposes thereof upon such security (not being shares of this Company), or without security and in such manner as they think fit, and from time to time to vary or realize such investments save as provided in Section 187 of the Act, all investments shall be made and held in the Company's own name;
- (12) To execute in the name and on behalf of the Companyin favour of any Director or other person who may incure be about to incur any personal liability whether us principal or surety, for the benefit of the Company, such mortgages of the Company's property (present and future) as they think fit, and any such mortgage may contain a power of sale and such other powers, provisions, convenants and agreements as shall be agreed upon:
- (13) To determine from time to time who shall be entitled to sign, on the Company's behalf, bills, notes, receipts, acceptances, endorsements, cheques, dividends, warrants, releases, contracts, and documents and to givethe necessary authority for such purpose;
- (14) To distribute by way of bonus amongst the staff of the Company, share or shares in the profits of the Company, and to give to any officer or other person employed bythe Company a commission on the profits of any particular business or transaction; and to charge such bonus or commission as part of the working expenses of the Company;
- (15) To provide for the welfare of Directors or ex-Directors or employees or ex-employees of the Company and their wives, widows and families or the dependents or connections of such persons, by building or contributingto the building of houses, dwellings or by grants of

money, pension, gratuities, allowances, bonus or other payments, or by creating and from time to time subscribing or contributing to provident and other associations, institutions, funds or trusts and providingor subscribing or contributing towards places of instruction and recreation, hospitals and dispensaries, medical and other attendance and other assistance as the Board shall think fit; and to subscribe or contributeor otherwise to assist or to guarantee money to charitable, benevolent, religious scientific, national or other institutions or objects which shall have any moralor other claim to support or aid by the Company, eitherby reason of locality of operation, or of public and generalutility or otherwise;

(16) Before recommending any dividend, to set aside out ofthe profits of the Company such sums as they may think proper for depreciation or to Depreciation Fund, or toun Insurance Fund, or as a Reserve Fund, or Sinking Fund or any Special Fund to meet contingencies or torepay Debentures or Debenture-stock, or for special dividends or for equalizing dividends or for repairing, improving extending and maintaining any of the propertyof the Company and such for other purposes (includingthe purposes referred to in the preceding clause), as the Board may, in their absolute discretion, think conduciveto the interest of the Company, to invest the several sums so set uside or so much thereof as required to be invested, upon such investments (other than shares of the Company) as they may think fit, and from time totime to deal with and vary such investments and disposeof and apply and expend all or any part thereof for the benefit of the Company, in such manner and for suchpurpose as the 'Board in their absolute discretion thinkconducive to the interest of the Company, notwithstanding that the mutters to which the Board apply or upon which they expend the same, or any part thereof, may be matters to or upon which the capital moneys of the Company might rightly be applied or expended; and to divide the Reserve Fund into such special Funds as the Board may think fit, with full power to transfer the whole or any portion of a Reserve Fundor division of, a Reserve Fund to another Reserve Fundor division of a Reserve Fund and with full power to employ the assets constituting all or any of the above Funds, including the Depreciation Fund, in the business of the Company or in the purchase or repayment of Debentures or Debenture-stock, and without being boundto keep the same separate from the other assets and without being bound to pay interest on the same withpower however to the Board at their discretion to pay or allow to the credit of such funds interest at such rate asthe Board may think proper,

- (17) To appoint, and at their discretion remove or suspend such general managers, managers, secretaries, assistants, supervisors, clerks, agents and servants of permanent, temporary or special services as they may from time to time think fit, and to determine their powers and duties, and fix their salaries of emoluments or remuneration, and to require security in such instances and to such amount as they may think fit. Also from time to time provide for the management and transaction of the affairs of the Company in any specified locality in India or elsewhere in such manner as they think fit, and the provisions contained in the four next following sub-clauses shall be without prejudice to the general powers conferred by this sub-clause:
- (18) To comply with the requirements of any local law whichin their opinion it shall, in the interests of the Company, he necessary or expedient to comply with:
- (19) From time to time and at any time to establish any Local Board for managing any of the affairs of the Company in any specified locality in India or elsewhereand to appoint any persons to be members of such Local Boards and to fix their remuneration.
- (20) Subject to Section 179 & 180 of the Act, from time to time and at any time, to delegate to any person so appointed any of the powers, nuthorities and discretion for the time being vested in the Board, other than their power to make calls or to make loans or borrow or moneys, and to authorise the Members for the time beingof any such Local Board, or any of them to fill up any vacancies therein and to act notwithstanding vacancies, and any such appointment or delegation may be madeon such terms and subject to such conditions as the Board may think fit and the Board may at any time remove any person so appointed, and may annual or vary any such delegation.
- (21) At any time and from time to time by Power of Attorney under the Seal of the Company, to appoint any personor persons to be the Attorney or Attorneys of the Company, for such purposes and with such powers, authorities and discretion (not exceeding those vested in or exercisable by the Board under these presents and excluding the powers to make calls and excluding also, except in their limits authorised by the Board, the powerto make loans and borrow moneys) and for such periodand subject to such conditions as the Board may frontime to time think fit; and any such appointment may (if the Board thinks fit) be made in favour of the members or any of the Members of any Local Board, established as aforesaid or in favour of any company, or the share-holders, directors, flominees, or managers of any

company or firm or otherwise in favour of my fluctuating body of persons whether nominated directly by the Board and any such Power of Attorney may contain such powers for the protection or convenience of persons dealing with such Attorneys as the Board may think fit, and may contain powers enabling any such delegates or attorneyses aforesaid to sub-delegate all or any of the powers, authorities and discretions for the time being vested in them:

- (22) Subject to Sections 188 of the Act, for or in relation toany of the matters aforesaid or otherwise for the purposes of the company to enter into all such contracts, and execute and do all such acts, deeds, and things in the name and on behalf of the Company as they may consider expedient;
- (23) From time to time to make, vary and repeal by-law forthe regulation of the business of the Company, its officers and servants.

## BOARD TO APPOINT CHIEF EXECUTIVE OFFICER/ MANAGER/ COMPANY SECRETARY/ CHIEF FINANCIAL OFFICER

- 172. a) Subject to the provisions of the Act,-
  - A chief executive officer, manager, company secretary or chief financial officer may be appointed by the Board for such term, at such remunerationand upon such conditions as it may thinks fit; and any chief executive officer, manager, company secretary or chief financial officer so appointed may be removed by means of a resolution of the Board;
  - A director may be appointed as chief executive officer, manager, company secretary or chief financial officer.
  - b) A provision of the Act or these regulations requiring or authorising a thing to be done by or to a director andchief executive officer, manager, company secretary or chief financial officer shall not be satisfied by its being done by or to the same person acting both as directorand as, or in place of, chief executive officer, manager, company secretary or chief financial officer.

## THE SEAL

The Seal, its custody and use 173. (a) The Board shall provide a Common Seal for the purposes of the Company, and shall have power from time to timeto destroy the same and substitute a new Seal in lieu thereof, and the Seal shall never be used except by the authority of the Board or a Committee of the Board previously given.

(b) The Company shall also be at liberty to have an official Seal in accordance with the Act, for use in any territory, district or place outside India.

174. Every Deed or other instrument, to which the Seal of the Company is required to be affixed, shall, unless the same is executed by a duly constituted attorney, be affixed in the presence of at least one Director or the Manager or the Secretary or such other person, appointed by the Board or Committee(s) thereof, who shall sign the instrument, providedthat in respect of Share Certificate the Seal shall be affixedin accordance with Article 27 (a).

Deeds how Executed

#### DIVIDENDS

175. The profits of the Company, subject to any special rights relating thereto created or authorised to be created by these Articles, and subject to the provisions of these Articles, shall be divisible among the members in proportion to the amount of capital paid-up on the shares held by them respectively.

Division of profits.

176. The Company in General Meeting may declare dividends to be paid to members according to their respective rights, but no dividends shall exceed the amount recommended by the Beard, but the Company in General Meeting may declare a smaller dividend.

The Company in General Meeting may declare a dividend

177. No dividend shall be declared or paid otherwise than out of the profits of the financial year arrived at after providing for depreciation in accordance with the provisions of section 123 of the Act or out of the profits of the Company for any previous financial year or years arrived at after providing for depreciation in accordance with these provisions and remaining undistributed or out of both, provided that;

Dividends only to be paid out of profits

- (a) if the Company has not provided for depreciation for any previous financial year or years, it shall, before declaring or paying a dividend for any financial year, provide for such depreciation out of the profits of the financial year or years;
- (b) If the Company has incurred any loss in any previous financial year or years, the amount of the loss or any amount which is equal to the amount provided for depreciation for that year or those years whichever is less, shall be set off against the profits of the Company for the year for which the dividend is proposed to be declared or paid or against the profits of the Companyfor any previous financial year or years arrived at both cases after providing for depreciation in accordance with provisious of Section 123 of the Act, or against both.
- 178. Notwithstanding with the provisions of Article, 176, the Board may from time to time decide to use any of the Company's Capital Profits, whether transferred to Reserves or otherwise,



for distribution by way of dividend to shareholders as in their judgement the position of Company justifies.

Interim dividend 179. The Board may, from time to time, pay to the Holders of Equity Shares such Interim Dividend as, In their judgement, the position of the Company justifies. Further, the Board maypay Interim Dividend to the Holders of Preference Shares orany other class of Shares as it may deem fit.

Capital paid up in advance at interest not to earn dividend 180. Where capital is paid in advance of calls, such capital mayoarry interest but shall not in respect thereof confer a right to dividend or participate in profits.

Dividends proportion amount paid181. All dividends shall be apportioned and paid proportionatelyto the amounts paid or credited as paid on the shares duringany portion or portions of the period in respect of which the dividend is puid, but if any shares is issued on terms providing that it shall rank for dividend as from a particular, date, such share shall rank for dividend accordingly.

Retention of dividends antil completion of transfer under Amele 60.

182. The Board may retain the dividends payable upon shares in respect of which any person is under the Article entitled tobecome a member or which any person under that Article is entitled to transfer; until such a person shall become amember, in respect of such shares or shall duly transfer thesame.

Dividend etc. to joint-holder. 183. Any one of several persons who are registered as the joint-holders of any share may give effectual receipts for all dividends or bonus and payments on account of dividends or bonus or other moneys payable in respect of such shares.

No members to receive dividend while indebted to the Company and Company's right of reimbursement thereout.

184. No member shall be entitled to receive payments of any interest or dividend in respect of his share or shares, while any money may be due or owing from him to the Company in respect of such share or shares or otherwise howsoever, either alone or jointly with any other person or persons and the Board may deduct from the interest or dividend payable to any member all sums of money so due from him to the Company.

Any General Meeting may resolve that any moneys, investments, or other assets forming part of the undivided profits of the Company standing to the credit of the Reserves,or any Capital Redemption Reserve Fund, or in the hands of the Company and available for dividend or representing premiums received on the issue, of shares and standing to the credit of the Share Premium Account be capitalised and distributed amongst such of the members as would be entitledto receive the same if distributed by way of dividend and in the same proportions on the footing that they become entitled thereto as capital and that all or any part of such capitalisedfund be applied on behalf of such members in paying up infully any unissued shares, debentures or debenture-stock of the Company which shall be distributed accordingly or in ortowards payment of the uncalled liability on any issued shares, and that such distribution or payment shall be accepted by such members in full satisfaction of their interest in the said capitalised sum; Provided that any sum standing to the credit of a Share Premium Account or a Capital Redemption Reserve Fund may, for the purposes of this Article, only be applied inthe paying up of unissued shares to be issued to members ofthe Company as fully paid bonus shares.

190. A General Meeting may resolve that any surplus money arising from the realisation of any capital assets of the Company orany investments representing the same, or any other undistributed profits of the Company not subject to charge for income tax, . be distributed among the members on the footing that they receive the same as capital.

For the purpose of giving effect to any resolution under the two last preceding Articles hereof the Board may settle any difficulty which may arise in regard to the distribution as it thinks expedient and in particular may issue fractional certificates, and may fix Certified True Copy the value for distribution of any

specific assets, and may determine that eash payment, shall be made, to any members upon the footing of the value sofixed in order to adjust the rights of all parties and may vest such cash or specific assets in trustees upon such trusts forthe persons entitled to the dividend or capitalised fund as may seem expedient to the Board. - 192. (1) The Company Shall keep at the office or at such other place in India as the Board thinks fit, proper Books of Account in accordance with Section 128 of the Act, with respect to

  - (b) All sales and purchases of goods by the Company,
  - (c) The Assets and liabilities of the Company.
  - (2) where the Board decides to keep all or any of the Booksof Accounts at any place other than the office of the Company the Company shall within seven days of the decision file with the Register a notice in writing givingthe full address of that other place.
  - (3) The Company shall preserve in good order the Books of Account relating to period of not less than eight yearspreceding the current year together with the vouchers relevant to any entry in such Books of Account.
  - (4) Where the Company has a branch office, whether in or outside India the Company shall be deemed to have complied with this Article if proper books of Account relating to the transactions effected at the branch officeare kept at the branch office and proper summarized returns made up to date at intervals of not more thanthree months are sent by the branch office to the Company at its office or other place in India, at whichthe Company's Books of Account are kept as aforesaid.
  - (5) The Books of Account shall give a true and fair view of the state of affairs of the Company or branch office, asthe case may be, and explain its transaction. The Books of Account and other books and papers shall be open to inspection by any Directors during business hours.
